172 children died of Influenza in the United States in 2017-2018. There are 73.7 million children living in the United States under the age of 18. That is 0.00000234 of all children in this country died of the flu. The question is...is that number going up or down with increased vaccination rates? Influenza vaccines have been around since 1945. Just before the flu season of 2003-2004 the CDC recommended for the first time that children younger than 60 months (5 years) and older than 6 months receive an annual flu vaccination.

About this time is when the fad of getting a flu vaccine became common for not only children under 5, but for everyone over 5 as well. [source [CDC.gov](#)] [source [vaccineinformation.org](#)]

The following is a list of different years and the number of flu associated deaths in children reported to the CDC:

1999-2000 -36 deaths

2000-2001 -30 deaths 17% decrease

2001-2002 – 25 deaths 17% decrease

2002-2003 – 29 deaths 16% increase (This is the last year that the flu vaccine was considered “unsafe” by the CDC for children under 5 – now let’s watch the increase of deaths after the CDC recommends all children age 6 months to 5 years be vaccinated for Influenza.)

2003-2004 – 153 427% increase

2004-2005 — 47 deaths 69% decrease

2005-2006 – 46 deaths 3% decrease

2006-2007 – 68 deaths 48% increase

2007-2008 – 88 deaths 29% increase

2008-2009 – 133 deaths 51% increase

2009-2010 – 282 deaths 112% increase

2010-2011 – 115 deaths 59% decrease

The number of children dying from the flu has risen \*drastically\* since the CDC recommended children under 5 receive the flu vaccine. There has been an average of 67% increase of flu-associated death in children since the CDC recommended children under 5 receive the flu vaccine.

According to research presented at the 105th International Conference of the American Thoracic Society in San Diego, children who get the flu vaccination have a 3 times greater risk for hospitalization:

They found that children who had received the flu vaccine had three times the risk of hospitalization, as compared to children who had not received the vaccine. In asthmatic children, there was a significantly higher risk of hospitalization in subjects who received the TIV (Stands for Trivalent Influenza Vaccine – a.k.a. the flu shot), as compared to those who did not.



Project MKUltra, also called the CIA mind control program, is the code name given to a program of experiments on human subjects that were designed and undertaken by the United States Central Intelligence Agency—and which were, at times, illegal. Experiments on humans were intended to identify and develop drugs and procedures to be used in interrogations in order to weaken the individual and force confessions through mind control. The project was organized through the Office of Scientific Intelligence of the CIA and coordinated with the U.S. Army Biological Warfare Laboratories. The operation was officially sanctioned in 1953, was reduced in scope in 1964, further curtailed in 1967, and recorded to be halted in 1973. The program engaged in many illegal activities, including the use of U.S. and Canadian citizens as its unwitting test subjects, which led to controversy regarding its legitimacy. MKUltra used numerous methods to manipulate people's mental states and alter brain functions, including the surreptitious administration of drugs (especially LSD) and other chemicals, hypnosis, sensory deprivation, isolation, verbal and sexual abuse, and other forms of torture.

Gulf War Syndrome, thanks to the anthrax vaccine.

U.S forces received experimental drugs, such as pyridostigmine bromide, and a different battery of vaccines, including anthrax vaccine and botulinum toxoid vaccine. No previous deployment in U.S. history had involved vaccination of large numbers of soldiers against biological agents.

American soldiers and civilian workers reported that they were suffering from debilitating symptoms such as severe fatigue, joint and nerve pain, headaches, memory loss, gastrointestinal issues, insomnia and respiratory and neurological disorders.<sup>4</sup> This cluster of acute and chronic multi-symptom illness affecting veterans of the Gulf War became known as the Gulf War illness or “Gulf War Syndrome.

In another significant legal win for vaccine risk awareness, non-profit Informed Consent Action Network (ICAN), a new Freedom of Information Act disclosure from the Federal Food and Drug Administration (FDA) has revealed that the MMR vaccine was licensed based on clinical trials which in total had less than 1,000 participants and far more adverse reactions than previously acknowledged.

“It’s alarming that an appeal was required to get this information, but it’s more alarming that every time ICAN prevails in obtaining a FOIA disclosure from the FDA, CDC or HHS, we learn about another serious shortcoming in their duties to assure Americans’ health and health care,” says Del Bigtree, ICAN founder and host of the weekly fact-based medical news show “The HighWire.”

The MMR vaccine is at the heart of the vaccine debate. The following are some of the key facts learned from the clinical trial reports produced by the FDA, which the agency relied upon to license the MMR:

There were eight clinical trials that in total had less than 1,000 individuals, out of which only 342 children received the MMR vaccine

The safety review period only tracked ‘adverse events’ for 42 days after injection

More than half or a significant percent of all participants in each of the eight trials developed gastrointestinal symptoms and upper respiratory infections

All adverse events were generically described as ‘other viruses’ and not considered in safety profile of licensure

The control group received other vaccines for either rubella or measles and rubella, and none of the controls received a placebo (an inert substance such as a saline injection)...But what's even more alarming is learning about the serious adverse events that were known and acknowledged, yet ignored in order to license the MMR vaccine. This was after only tracking adverse events for 42 days after injection – imagine what they might have found had they tracked safety for three years (autism) against an appropriate control, like they do for drugs.

- In fact, the manufacturers of flu and Tdap vaccines WARN against their use for pregnant mothers since their safety has never been established.
- The package inserts  state that it is "not known" whether the vaccines "will harm an unborn baby" and there are "insufficient data" on use in pregnant women to inform vaccine-associated risks.
- The FDA regulations strictly prohibit pharmaceutical companies from marketing products for "off-license" uses. Noncompliant companies are routinely prosecuted criminally and civilly, paying billions in lawsuits and settlements.
- Yet- The CDC has actively recommended influenza vaccination during any trimester of pregnancy since 2004 and has told pregnant women to get Tdap shots (for tetanus, diphtheria and pertussis) since 2011.
- The FDA is responsible for vaccine safety and licensing, but, it admits that it has no safety data to back up the CDC's "off-license" pregnancy recommendations.
- FDA's website states that it has never formally approved any vaccines "specifically for use during pregnancy to protect the infant."

## 7. Association Between Prenatal Exposure to Metals and Neonatal Morbidity

The CP ratio was higher (1) in subjects with AI, (2) in mothers to newborns diagnosed as small-for-gestational age (p value = .052), (3) neonates that weighed less (p value = .079), and (4) in women who experienced repeated abortions (p value = .049). ## 8. We identified 671 reports after seasonal influenza vaccines administered to pregnant women: 544 after IIV and 127 after LAIV. Serious events occurred among 61 (11.2%) reports following IIV and one (0.8%) report following LAIV. No deaths were reported.

Among reports with trimester information (n = 296), IIV was administered during the first trimester in 116 (39.2%). Among IIV reports, the most frequent pregnancy-specific AE was spontaneous abortion in 62 (11.4%) reports, followed by stillbirth in ten (1.8%) and preterm delivery in six (1.1%). The most common non-pregnancy-specific AEs were injection-site reactions (55 [10.1%]). Neonatal or infant outcomes were reported in 22 (4.0%) reports, seven of which had major birth defects of different types and no neonatal deaths.


